This letter is in regards to your request for records:

# Hydro bills for each institution (University Hospital; Victoria Hospital; South Street Hospital; Children's Hospital) dating back to 2011/2012, broken down by institution.

### **Final Decision:**

The hospital has made a decision regarding the release of the information you have requested.

Our decision is to release the information you have requested in full. Please find the hydro costs for the Victoria Hospital site (which includes the Children's Hospital of Western Ontario), University Hospital site and South Street Hospital site for the years 2011-2017 presented in the chart below.

(Please note that LHSC began a multi-year process of decommissioning and demolishing South Street Hospital in 2013-2014).
