

Ontario Debt, Spending & Taxes

Ontario's Provincial Debt1

- Ontario's total debt has increased by \$110 billion since Dalton McGuinty became premier²
- Ontario's debt will reach \$257.9 billion by the end of 2011³
- If Dalton McGuinty remains premier, he will have overseen the doubling of Ontario's debt by December 10, 2012.
- Ontario's debt is currently increasing by \$59 million per day, or \$685 per second
- Ontario's debt will increase by \$66.8 million per day in 2012-13, or \$773 per second

Interest on Debt

- Ontario pays \$10.3 billion a year just to pay the annual interest on its debt
- Debt interest cost taxpayers \$28.2 million per day, or \$327 per second
- Without having to pay interest on its debt, Ontario could:
 - o Eliminate half of its deficit
 - Cut income taxes by 44%
 - o Reduce the HST by 4%
- Ontario's debt interests costs are equivalent to:
 - o 89% of the federal health care transfer
 - o 20% of the Department of Health's budget
 - o 43% of the Department of Education's budget
 - 125% of the Department of Training, Colleges and Universities Budget
 - o 381% of the Department of Transportation's budget

Spending Increases

- Total spending has increased by 64% since Dalton McGuinty became premier
- The Ontario government spends \$44 billion more per year in 2011 than it did when Dalton McGuinty became premier

Tax Increases

- Breaking his written Taxpayer Protection Pledge with the CTF, the McGuinty government has introduced or raised the following taxes:
 - o Ontario Health Tax, a tax grab currently costing Ontarians \$2.7 billion a years
 - o Eco-Taxes, \$39 million
 - o Hidden Hydro Tax, \$53 million
 - o Electronics taxes, \$71 million
 - Tire Taxes, \$70 million
 - Beer, wine and spirit taxes
 - Toronto Land Transfer Tax
 - o Toronto vehicle registration fees
- While not a direct tax hike, Premier McGuinty failed to obtain a mandate from voters in an election or referendum to move from a PST to HST, adding taxes to thousands of items including:
 - o Gasoline
 - Private resale of automobiles
 - o New homes over \$400,000
 - Sports and fitness fees

Unsustainable pension contributions to government workers

- The McGuinty government is borrowing money to make multi-billion dollar contributions to private pension plans controlled by government workers.
 - Currently, the Ontario Teachers Pension Plan (OTPP) holds 80% of its equities in oversees investments.⁴ A minimum of \$47 billion of the plan's \$104.7 billion in total assets are invested offshore.
 - While Ontario goes deeper into debt in part to fund massive public sector pension plans, the OTPP buys a significant portion of that Ontario debt. Added together, the OTPP owns \$5.3 billion in Ontario debt.

McGuinty in His Own Words

- "I, Dalton McGuinty, leader of the Ontario Liberal Party, promise, if my party is elected as the
 next government, that I will: Not raise taxes or implement any new taxes without the explicit
 consent of Ontario voters; And not run deficits. I will abide by the Taxpayer Protection Act."

 —Taxpayer Protection Pledge, September 11, 2003
 - In his first budget as premier, McGuinty introduced the largest single tax increase in Ontario's history in the form of the Health Premium.
- "At the time of the last election, I told Ontarians that I wouldn't raise their taxes. And I broke that promise. And I did raise their taxes.
 - Liberal re-election advertisement, September 2007
- "I am here to tell you that we found something in the cupboard: a \$5.6 billion Tory deficit. We are going to eliminate it so we can implement our promises."
 - Speech to the Economic Club of Toronto, October 30, 2003
 - After using the \$5.6 billion Tory deficit as a pretext for raising taxes, McGuinty increased the deficit to a record \$35.2 billion in 2009-10 as measured by annual change in total debt
