## Re: Your request for information under The Freedom of Information and Protection of Privacy Act (FIPPA) – Our File No. 2014-46

Thank you for your Application for Access under *The Freedom of Information and Protection of Privacy Act* (FIPPA) which was received by Manitoba Justice on April 11, 2014.

## You requested:

"Please provide documentation on the number of inmates or people in custody who have been accidentally released since January 1, 2010. Please break out the number of incidents by year (calendar or fiscal is ok), when person was accidentally let go and when they were taken into custody again.

One of the purposes of FIPPA is to allow any person a right of access to records in the custody or under the control of a public body, subject to limited and specific exemptions, which are set out in the Act.

Access is granted to your request. I can advise that, based on fiscal year, the number of inmates or people in custody who have been accidentally released is as follows: 2010/11 - 15; 2011/12 - 7; 2012/13 - 6; 2013/14 - 9, 2014/15 - 1. Please note that in keeping with the desire to be transparent the numbers of inmates or people in custody who have been accidentally released is reported annually in our Annual Report.
