I am writing regarding your request under the Right to Information and Protection of Privacy Act received on June 19, 2017 regarding:

Please provide documentation on any reports or analysis on demographic shifts (aging population) in New Brunswick occurring in the future and how that relates to future revenues, expenditures and debt levels. Note: The Federal government produces a "Fiscal Sustainability Report" each year that looks at long-term revenue and expenditure forecasts and projected fiscal gaps (primarily due to an aging population). That's the type of report or material that I'm looking for, but from the province's perspective.
