About the Canadian Taxpayers Federation

The Canadian Taxpayers Federation is a federally incorporated, not-for-profit citizens' group dedicated to lower taxes, less waste and accountable government.

The CTF was founded in Saskatchewan in 1990 when the Association of Saskatchewan Taxpayers and the Resolution One Association of Alberta joined forces to create a national organization. At the end of 2020, the CTF had over 235,000 supporters nationwide.

The CTF maintains a federal office in Ottawa and regional offices in British Columbia, Alberta, Prairie (Saskatchewan and Manitoba), Ontario, Québec and Atlantic Canada. Regional offices conduct research and advocacy activities specific to their provinces in addition to acting as regional organizers of Canada-wide initiatives.

CTF offices field hundreds of media interviews each month, hold press conferences and issue regular news releases, commentaries, online postings and publications to advocate on behalf of CTF supporters. CTF representatives speak at functions, make presentations to government, meet with politicians and organize petition drives, events and campaigns to mobilize citizens to effect public policy change. Each week CTF offices send out Let's Talk Taxes commentaries to more than 800 media outlets and personalities across Canada.

Any Canadian taxpayer committed to the CTF's mission is welcome to join at no cost and receive emailed Action Updates. Financial supporters can additionally receive the CTF's flagship publication The Taxpayer magazine, published three times a year.

Overview

The Gas Tax Honesty Report highlights the hidden taxes Canadians pay every time we fill-up. Gas taxes include the sales taxes you see on your receipt, but also the federal excise tax, provincial excise tax and carbon taxes you don't see. In some cities, you also pay a hidden transit tax.

The federal government requires all provinces, except Quebec, to pay its mandatory minimum carbon tax rate. Despite the pandemic and high inflation, the federal government raised its carbon tax every year since 2019, reaching \$65 per tonne on April 1, 2023. Ottawa plans to further increase the carbon tax by \$15 per year until it hits \$170 per tonne in 2030.


The carbon tax currently costs about 14.3 cents per litre of gasoline. By 2030, the carbon tax is expected to cost about 37.4 cents per litre of gasoline.

Quebec imposes a cap-and-trade carbon tax scheme, which charges lower amounts per tonne than the federal backstop.

On July 1, 2023, the federal government imposed its carbon tax on New Brunswick, Nova Scotia, Prince Edward Island and Newfoundland and Labrador.

In Alberta, the entire tax bill at the pumps is federal.

All the gas and diesel price information in this report is from Kalibrate's price information for the third week of July 2023.





Canadian Gas Taxes

Gas Price Ranking

Victoria has the highest gas prices in the country at \$1.95 per litre (third week of July average), with 71 cents of the total being tax. Vancouver has the second highest pump prices at \$1.94 per litre. The difference between the three regions of British Columbia is partly explained by the transit taxes in Vancouver (18.5 cents per litre) and Victoria (5.5 cents per litre).

Tax Changes Since Last Year

The federal carbon tax increased from 11.1 to 14.3 cents per litre of gasoline, raising taxes on drivers in Alberta, Saskatchewan, Manitoba, Ontario, New Brunswick, Nova Scotia, P.E.I. and Newfoundland and Labrador.

B.C.'s provincial carbon tax also increased from 11.1 to 14.3 cents per litre of gasoline this year.

The federal government imposes a minimum carbon tax on all the provinces, except Quebec. Should provincial governments have carbon taxes lower than the federal minimum, it imposes its own carbon tax. B.C. charges its own provincial carbon tax that matches the rate of the federal tax.

The federal government increased its carbon tax to \$65 per tonne from \$50 on April 1, 2023. On July 1, 2023, it also imposed its own carbon tax on New Brunswick, Nova Scotia, P.E.I. and Newfoundland and Labrador, raising the tax on gas in Atlantic Canada by as much as 12 cents per litre above the previous provincial tax rate.

The federal carbon tax will increase from the current \$65 per tonne to \$80 in 2024, and then by a further \$15 every year until it reaches \$170 per tonne in 2030. By 2030, the \$170 per tonne carbon tax will cost about 37.4 cents per litre of gasoline.

The federal government also imposed a second carbon tax through fuel regulations that will add up to 17 cents per litre of gasoline in 2030. All together, Canadians will pay up to 54.4 cents per litre of gasoline in carbon taxes alone by 2030. The cost of this second carbon tax in 2023 is unclear in some provinces, but due to the centrally-regulated fuel prices in New Brunswick, Nova Scotia, P.E.I., and Newfoundland and Labrador, it has been announced that the tax will initially be between about four and eight cents per litre in Atlantic Canada. Here are the current second carbon tax rates in Atlantic Canada as of July 2023.

Drivers in B.C. already pay a second carbon tax through provincial fuel regulations, which increases the price of gasoline by about 17 cents per litre.



Tax On Tax

Every time you buy gasoline, you are charged a tax-on-tax. That's because some governments calculate sales taxes after all the per-litre taxes are added. That means you pay taxes on all the per-litre taxes governments added to the price. The tax-on-tax costs the average Canadian driver an extra 4.1 cents per litre of gasoline, on average.

Taxes in 2030

The Trudeau government is planning on increasing the federal carbon tax by \$15 per tonne every year until 2030. By then, it will reach \$170 per tonne, or 37.4 cents per litre of gasoline.

In 2030, Quebec's cap-and-trade carbon tax will be about <u>23</u> cents per litre, or roughly 14 cents lower than the carbon tax in the rest of Canada.

In 2030, the second federal carbon tax will also add up to 17 cents per litre, according to the Parliamentary Budget Officer. Altogether, Canadians will pay up to 54.4 cents per litre of gasoline in carbon taxes alone. Drivers in B.C. already pay a second carbon tax through provincial fuel regulations, which adds about 17 cents per litre to the price of gasoline.

The breakdown below shows the total tax bill Canadians can expect to pay in 2030. This assumes that the pre-tax gas price remains the same as it was during the third week of July 2023. In 2030, Canadians will pay 97 cents per litre of gasoline in taxes alone, on average.
