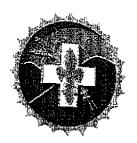

#### Excerpts from 2009 Indemnity By-law

#### **Annual Indemnity**

The total annual indemnity for the Reeve shall be Three Thousand Dollars (\$3000.00).

#### **Meeting Indemnity**

The Reeve shall be compensated for each regular council meeting attended, and he/she shall be paid at a rate of Two Hundred and Fifty Dollars (\$225.00) per meeting.

#### Per Diem Indemnity

The Reeve shall be compensated for attending any special and committee meetings, and seminars, conferences or conventions on behalf of the municipality provided that previous authorization was given by a resolution of council, and shall be paid at a rate of: One Hundred and Fifty Dollars (\$150.00) per day for a meeting, seminar, conference or convention that is attended for four hours or more. AND One Hundred Dollars (\$100.00) per day for a meeting, seminar, conference or convention that is attended for four hours or less.

#### **Annual Indemnity**

## **Annual Indemnity**

The total annual indemnity for the Deputy Reeve and Councillors shall be Two Thousand Dollars (\$2000.00).

## **Council Meeting Indemnity**

The Deputy Reeve and Councillors shall be compensated for each regular council meeting attended, and he/she shall be paid at a rate of Two Hundred and Fifty Dollars (\$225.00) per meeting.

#### Per Diem Indemnity

The Deputy Reeve and Councillors shall be compensated for attending any special and committee meetings, and seminars, conferences or conventions on behalf of the municipality provided that previous authorization was given by a resolution of council, and shall be paid at a rate of: One Hundred and Fifty Dollars (\$150.00) per day for a seminar, conference or convention that is attended for four hours or more. One Hundred Dollars (\$100.00) per day for a meeting, seminar, conference or convention that is attended for four hours or less.

# Indemnity and Expenses for Duties Other Than Ward Duties

The Deputy Reeve and Councillors shall be compensated for actual time spent attending to matters that do not fall under general duties of Council at the rate of Twenty Dollars (\$20.00) per hour.

## **CHAIRMAN OF WORKS AND OPERATIONS:**

The Chairman of Works and Operations will be paid an annual indemnity of One Thousand, Six Hundred Dollars (\$1400.00).
