This letter is in response to your Application for Access under <u>The Freedom of Information and Protection of Privacy Act (FIPPA)</u> dated October 17, 2013. I have enclosed a copy of your Application for your ease of reference.

In answer to your question, no such record exists. Property tax is an "ad valorem" tax. It is a tax based on the value of real property or personal property. As such, the city does not conduct any affordability analysis before it makes a property tax increase.

Please be advised that pursuant to Part 5 of <u>The Freedom of Information and Protection</u> of <u>Privacy Act</u>, you have the right to file a complaint with the Provincial Ombudsman within 60 days of the date of this letter.
