RE: Your request for access to information under Part 2 of *The Freedom of Information and Protection of Privacy Act* (Our File Number: #128)

On March 1, 2012 the MLCC received your request for access to the following records:

Provide documentation on Winnipeg Jets tickets purchased or received. Further, please include details on any usage of luxury boxes during Winnipeg Jets games. If tickets were purchased, please provide a breakdown on how many tickets were purchased, cost and section (luxury box, upper deck, etc.)

If tickets were provided rather than directly purchased (eg. as a gift for advertising), please provide documentation on why the tickets were provided.

For all tickets, please indicate who used the tickets – I understand names will be not likely be disclosed, but please indicate division.

I am pleased to inform you that your request for access has been granted in full.

For financial reasons and as part of the MLCC's objective to act as a good corporate citizen and to support the communities in which we operate, the MLCC entered into a sponsorship agreement with TrueNorth Sports & Entertainment Limited. The agreement gives the MLCC exclusive rights to use the Winnipeg Jets name/logo in the retail environment within the Winnipeg Jets market place for spirits, wine and refreshment beverages. It includes full page advertisements in each game day program, advertisements on the electronic "PowerRing" 10 times per game, two 12' by 8' signs displayed in the main concourse, and a backlit sign in the MTS Centre public walkway. These opportunities are used for both Liquor Mart and social responsibility program advertisements.

In addition, the agreement includes 10 tickets for each Winnipeg Jets game. The tickets are located as follows: 8 seats in lower bowl 100 level and 2 tickets in upper 300 level. Further, the MLCC has not used or purchased any tickets in any luxury boxes for the Winnipeg Jets. See attached schedule for details of ticket distribution.
