FOIP Services provides access to records.

Our response with a listing of a Cabinet Minister government vehicles and fuel costs was provided to you on July 17, 2018. The following additional information was also included in the final letter:

· In some instances more than one vehicle was assigned to a Minister due to circumstances (such as a vehicle assigned from the vehicle pool to a Minister until the Minister made a decision for a vehicle, Minister bought out existing vehicle and replaced it with another one, etc). In these cases, a Minister may have been assigned another vehicle in the same fiscal year.

To assist you further, the following contextual information has been provided regarding reimbursements for fuel costs:

- · Regarding carbon tax reimbursements, the carbon levy is built into each fuel purchase and is not reimbursed.
 - In 2017 0.0449 per L of gasoline, 0.0535 per L of diesel
 - o In 2018 0.0673 per L of gasoline, 0.0803 per L of diesel
- Reimbursements that are made to a Member of the Legislative Assembly (MLA) are published quarterly and are available at the following website: http://www.assembly.ab.ca/net/index.aspx? p=edr_home. This would include fuel reimbursements for MLAs that are not issued a government vehicle.
- Executive vehicles are a taxable benefit and as such individuals are required to complete and submit the applicable tax forms with their individual tax return.

Regarding reimbursements for personal use, your request scope was as follows:

Please provide documentation on the cost of government vehicles provided to cabinet ministers in 2017-18, vehicle type (eg. 2017 Toyota Corolla), total fuel costs for each minister, and data on any reimbursements by the ministers for fuel costs or specifically for the carbon tax. A summary table is preferable.

Timeframe: April 1, 2017 to March 31, 2018.

The way your request scope was written does not address reimbursements for personal use. I can look into this further and provide you with further information.

Note – we continue to process your request SA 2018-G-0035 for the following information:

Documentation indicating the type of government vehicle provided to the Premier in 2017-18, the cost of fuel for that vehicle in 2017-18 as well any reimbursements by the Premier for fuel costs. (A summary table or note is preferred). Eliminate drafts and duplicates.

Timeframe: April 1, 2017 to March 31, 2018
