# About the Canadian Taxpayers Federation

The Canadian Taxpayers Federation is a federally incorporated, not-for-profit citizens' group dedicated to lower taxes, less waste and accountable government.

The CTF was founded in Saskatchewan in 1990 when the Association of Saskatchewan Taxpayers and the Resolution One Association of Alberta joined forces to create a national organization. At the end of 2020, the CTF had over 235,000 supporters nationwide.

The CTF maintains a federal office in Ottawa and regional offices in British Columbia, Alberta, Prairie (Saskatchewan and Manitoba), Ontario, Québec and Atlantic Canada. Regional offices conduct research and advocacy activities specific to their provinces in addition to acting as regional organizers of Canada-wide initiatives.

CTF offices field hundreds of media interviews each month, hold press conferences and issue regular news releases, commentaries, online postings and publications to advocate on behalf of CTF supporters. CTF representatives speak at functions, make presentations to government, meet with politicians and organize petition drives, events and campaigns to mobilize citizens to effect public policy change.

Any Canadian taxpayer committed to the CTF's mission is welcome to join at no cost and receive emailed Action Updates. Financial supporters can additionally receive the CTF's flagship publication *The Taxpayer* magazine, published three times a year.

The CTF is independent of any institutional or partisan affiliations. All CTF staff, board members and representatives are prohibited from donating to or holding a membership in any political party. In 2019-20, the CTF raised \$4.8 million on the strength of 39,792 donations. Donations to the CTF are not tax deductible as a charitable contribution.



# Introduction

Taxpayers deserve to know how their mayors and councillors are spending their tax dollars. And they deserve to know how much other municipalities are spending in comparison.

The Saskatchewan government promised to help taxpayers with this basic transparency by posting municipalities financial information online. The province hasn't gotten it done.

**So, at the Canadian Taxpayers Federation, we rolled up our sleeves and did it ourselves.**

This report shows the per person spending levels for Saskatchewan's cities and towns in 2021. It highlights the cities and towns that spent the most and least per person. And we're providing the financial statements for all of the municipalities.

Municipalities are required by law to send a copy of their financial statements to the provincial government. The government used to publish these financial statements online, but stopped in 2008. The government promised to have a new system in place by 2021. "All of the municipalities will be required on an annual basis to actually be entering this information into that database," former Minister of Government Relations Lori Carr said. That has not happened.

Other provinces, such as Alberta and Ontario, have easy-to-use web portals where taxpayers can access municipal financial documents. Saskatchewan should be no different.

**The Canadian Taxpayers Federation is calling on the Saskatchewan government to proactively publish municipal financial statements online.**

In the meantime, the CTF collected the financial statements and published them on a website. It's a simple project, but it provides important transparency. And it highlights an obvious point: the provincial government should have gotten this done years ago.

# ANALYSIS: 2021 per person spending in Saskatchewan municipalities

## Saskatoon and Regina

As the two largest cities in the province, the CTF highlighted the spending growth in these two municipalities.

Over the five-year period between 2017 and 2021, Regina increased per-person spending by 10 per cent while Saskatoon increased it by 13 per cent. Saskatoon spent more per person in 2021 than Regina at \$3,161 and \$2,760 respectively.

## Medium and Small Cities

Of the other cities in the province, Swift Current spent the most per person in 2021 at \$3,741. Martensville spent the least per person at \$1,794.

The annual average per person spending of these cities was \$2,635 in 2021.

## Towns

In 2021, the average per person spending among towns in Saskatchewan was \$2,248. The town of Luseland spent the most at \$4,933 per person, while the town of St. Brieux spent the least at \$1,299 per person.

The top five town towns that spent the most in 2021 were Luseland, Lampman, Coronach, Kyle, and Blaine Lake. The five towns that spent the least were St. Brieux, Waldheim, Sturgis, Francis, and Rouleau.
