Your access to information request under *The Freedom of Information and Protection of Privacy Act* (the Act) was received in this office on June 10, 2010, requesting access to information. You wrote "Please provide documentation of expenditures on promotional items in 2008-09 and 2009-10. Include items such as t-shirts, hand bags, stress balls, key chains, mugs and other give-away items that are used for promotion (do not include brochures, flyers or printed signage). Further, please include a breakdown of costs associated with sponsorship of events (list events – golf tournaments, hockey tournaments, etc.), teams or groups (eg: sponsorship of boat racing team, etc.)".

This is to inform you that your access request has been fully granted. Below is a summary of the information you requested.
