RE: Your Access to Information Request No. SEI-01-2010G

Thank you for your access to information request received in this office on June 10, 2010, requesting:

"Please provide a breakdown of expenditures on promotional items in 2008-09 and 2009-10. Include items such as t-shirts, hand bags, stress balls, key chains, mugs and other give-away items that are used for promotion (do not include brochures, flyers or printed signage). Further, please include a breakdown of costs associated with sponsorship of events (list events – golf tournaments, hockey tournaments, etc.), teams or groups (i.e. sponsorship of a boat racing team, etc.)."

It was subsequently clarified that you were inquiring with respect to the fiscal years of 2008 and 2009, and that you were not seeking original records but would be satisfied with a summary of expenses. As well, it was clarified in your phone conversation with Owen Rice of our office on June 15, 2010, that you wanted both: (a) sponsorship expenditures (being those cash and/or merchandise expenses reflected in SaskEnergy's community investment activities) ("Part A Information"); and (b) promotional expenditures of various business and geographic units within SaskEnergy and TransGas where items are given away in furtherance of the customer or business relationship ("Part B Information").

The Part A Information is contained in a database that requires an electronic retrieval process in order to provide the breakdown requested. The Part B Information is not centrally tracked and in order to identify these records, each applicable department and area office will have to search for and prepare applicable records for disclosure. Therefore, in order to fully process your access request, the following fees will be necessary (please note the different allocation of hours based on Part A and Part B Information):

If you would like to exercise your right to request a review of this decision, you may do so by completing a "Request for Review" form and forwarding it to the Saskatchewan Information and Privacy Commissioner within one year of this notice.
