Re: Freedom of Information and Protection of Privacy (FOIP) Act

Service Alberta (SA) has reached a decision about your request for information under the FOIP Act for access to:

Please provide documentation on the cost of government vehicles provided to cabinet ministers in 2017-18, vehicle type (eg. 2017 Toyota Corolla), total fuel costs for each minister, and data on any reimbursements by the ministers for fuel costs or specifically for the carbon tax. A summary table is preferable.

Timeframe: April 1, 2017 to March 31, 2018

SA is pleased to provide full disclosure to the information you requested. The decision to grant full disclosure was made by the delegated authority of SA. A copy is enclosed.

Please also be advised the following:

 In some instances more than one vehicle was assigned to a Minister due to circumstances (such as a vehicle assigned from the vehicle pool to a Minister until the Minister made a decision for a vehicle, Minister bought out existing vehicle and replaced it with another one, etc). In these cases, a Minister may have been assigned another vehicle in the same fiscal year.

You have the right to ask the Office of the Information and Privacy Commissioner (OIPC) to review any decision made in regards to a FOIP request under section 65 of the FOIP Act. To request a review, you must complete and deliver a Request for Review form within 60 days to the OIPC at 410, 9925 – 109 Street, Edmonton, Alberta, T5K 2J8. The form is available under the "Resources" tab on the OIPC website at: <a href="www.oipc.ab.ca">www.oipc.ab.ca</a> or you can call them at 780-422-6860 or toll free at 1-888-878-4044 to request a copy of the form.

If you request a review, please provide the OIPC with a copy of your original request, any letters of clarification, a copy of this letter and the reason why you are requesting a review. Your request for review should not contain any information you do not wish to exchange with the other parties.
