Re: Your Access to Information Request PSC 1112-02G

Thank you for your access to information request received in this office on May 16, 2011, requesting access to, "Please provide documentation on sick days, sick days per full-time equivalent, FTE's, sick dollars paid and sick days accrued. Distinguish between in-scope and out of scope, provide overall totals. (same data as PSC 1011-02G but for 2010-11 year)"

This is to inform you that your access request has been fully granted, with one small exception -- per section 24(1) of *The Freedom of Information and Protection of Privacy Act* (the Act); the information for one identifiable was removed from the calculations. Enclosed is a record containing the number of sick days, sick days per full-time equivalent, FTEs, sick dollars paid and sick days accrued. As requested, the reports show the breakdown by ministry (department), in-scope and out-of-scope, and overall totals.

For your information, I have included a copy of the above-noted section of the Act.

If you would like to exercise your right to request a review of this decision, you may do so by completing a "Request for Review" form and forwarding it to the Saskatchewan Information and Privacy Commissioner within one year of this notice.
