

CTF background information on expense claims made by Glen Laubenstein and Sudhir Sandhu

The following is a summary of *notable* expense claims made by Glen Laubenstein and Sudhir Sandhu, formerly employees of the Regional Municipality of Wood Buffalo (RMWB), obtained through Freedom of Information (FOI) requests. The Canadian Taxpayers Federation (CTF) does not consider all expenses listed below as necessarily inappropriate, but rather to be of notable or potential interest. Similarly, expenses listed in the FOI documents may be questionable, but have not been flagged by the initial examination by the CTF.

The public and other interested parties are strongly encouraged to view the original documents for themselves and come to their own, independent conclusions.
