This letter is further to the request you submitted under the Access to Information Act for:

"Please provide information on the amount of spoiled fish (by weight and species) that have been sent to the dump during the last three fiscal years (2006/07-2208/09). Wherever possible, please provide information and the date harvested, when the fish was sent from the packing station to the Transcona plant and the date of disposal. Please include information on why shipments were sent to the dump – for example "misplaced semi-trailer. Further, please include information on the staff complement, by job classification and salary range."

Enclosed within please find staff information requested by job classification and salary range. Also, I have included summary information for years 2006/07, 2007/08 and 2008/09 of spoiled fish as per our telephone conversation of Friday, November 27, 2009.
