Information on exempt purchases (sales) of tobacco on native reserves in Nova Scotia. Dates should include fiscal years ending in 2001 to 2011 (if possible 2011-2012). Information should contain exempt tobacco volume (taxable units) and foreign tobacco tax revenue. (Please see page 78 in overview of the NS Tax system Table 58. Please also include the maximum allowable quota."
